

Domino's "Is the Domino Worthy" Promotion Terms

OFFERS ARE AVAILABLE ON A FIRST-COME, FIRST-SERVED BASIS, WHILE SUPPLIES LAST. QUANTITIES ARE LIMITED.

1. DESCRIPTION: The Domino's "Is the Domino Worthy" Promotion (the "**Promotion**") begins on or after Monday, August 31, 2026, at 12:00:01 am Eastern Time ("**ET**") and ends on Wednesday, September 30, 2026, at 11:59:59 pm ET or when all available Offers, as detailed below, are depleted, whichever comes first (the "**Offer Period**"). The Promotion sponsor is Domino's National Advertising Fund Inc., 30 Frank Lloyd Wright Drive, Ann Arbor, Michigan 48106 ("**Sponsor**"). The Promotion administrator is Creative Zing Promotion Group, 2100 E Robinson Street, Orlando, FL 32803 ("**Administrator**"). The Sponsor and Administrator are collectively referred to as the "**Promotion Entities**".

During the Offer Period, eligible Participants (as defined in [Section 2](#)) are extended the opportunity to complete an online form (the "**Form**") to request and reserve one (1) free "Domino" Pizza code (the "**Offer**"). Eligible Participants who accurately complete the Form will receive an email with instructions to authenticate their email address to complete the Offer claim process (the "**Offer Claim**") as detailed below. Failure by a Participant to authenticate their email address within five (5) minutes, as instructed, will result in forfeiture of the Offer. Offers are available on a first-come, first-served basis while supplies last. Completing the Form does not guarantee the availability of the Offer. Unclaimed Offers will go unawarded.

2. ELIGIBILITY: The Offer is open only to legal U.S. residents physically residing in the fifty (50) United States or the District of Columbia who are at least thirteen (13) years of age at the time of entry and who meet all other requirements in these Terms (each a "**Participant**"). If the Participant is under the legal age of majority in their state of primary residence (a "**Minor**"), one of the Participant's parents or legal guardians agrees that they have read, understood, and agreed to the Terms and that such agreement constitutes acceptance of these Terms on behalf of Participant and themselves. Employees of Promotion Entities, and each of their respective franchisees, subsidiaries, agencies, shareholders, officers, directors, members, successors, agents, and assigns, together with the Immediate Family Members and/or Household members of such persons, are not eligible to participate in the Promotion or claim the Offer. For purposes of the Promotion, "**Household**" means those people who share the same residence at least three months a year, whether or not related; "**Immediate Family Members**" means parents, stepparents, legal guardians, children, step-children, siblings, step-siblings, or spouses, regardless of where they live. A Domino's Rewards profile is NOT required to participate in the Promotion. The Promotion is void where restricted or prohibited by law.

3. HOW TO REQUEST & CLAIM THE OFFER: There are two (2) ways to request and claim an Offer, as follows:

- A. Receipt Upload:** Eligible Participants must visit www.isthedominoworthy.com during the Offer Period and follow the on-screen instructions to complete the Form by providing their full name, mailing address, and their valid email address to reserve an Offer. The email address associated with the reserved Offer is subject to verification and compliance with these Terms. Next, the Participant must upload a photo or screenshot of their one (1) receipt showing the purchase of any variation of one (1) of the following items (each a "**Qualifying Item**") from the corresponding fast food restaurant (the "**Receipt**") during the Offer Period:
- a. Any McDonald's Big Mac
 - b. Any Burger King Whopper
 - c. Any Taco Bell Crunch Wrap Supreme
 - d. Any Chipotle Burrito
 - e. Any Chick-fil-a Chicken Sandwich

Receipt upload must include the entire receipt from top to bottom, including all four (4) corners. Be sure that the required information is captured in the receipt, which includes retailer name, date of purchase, receipt total and at least one (1) Qualifying Item ("**Required Information**"). All Required Information must be legible in your image. For longer receipts, you may upload a picture of the receipt folded ensuring that it shows the Required Information. Blurry and/or unreadable Receipt images will be rejected.

If the email address provided to reserve an Offer is valid, the Participant will receive an email from confirmation@isthedominoworthypromo.com within approximately one (1) minute of Form submission with a multi-digit numeric verification code. The Participant must follow the on-screen instructions to

authenticate and validate their email within five (5) minutes of completion of the Form, using the provided code, or the Offer reservation will be forfeited and reallocated to the available Offers. Once the Participant enters the provided code to complete the Offer reservation process, the submitted Receipt will be validated for inclusion of a Qualifying Item. If a Participant reserves an Offer but fails to authenticate their email address and complete the Offer reservation within the specified time, such Participant will remain eligible to reserve another Offer, subject to availability. If the Receipt is validated, the Offer Claim will be confirmed and the Participant will receive an email with their "Offer Code", as detailed below, along with redemption instructions. IF THE RECEIPT IS NOT VALIDATED, OFFER CLAIM WILL NOT BE CONFIRMED, AND PARTICIPANT WILL NOT RECEIVE AN OFFER CODE. The Participant is responsible for checking their spam folder and email settings. Promotion Entities are not responsible for lost, expired, overlooked, rejected, or misplaced authentication emails.

- B. Alternate Method of Participation:** To participate without submitting a Receipt, eligible Participants must visit www.isthedominoworthy.com/ during the Offer Period, select the "free method of entry" link located under the "Receipt Upload" Form, and follow the on-screen instructions to complete the AMOE Form by providing their full name, mailing address, and valid email address to reserve an Offer. The email address associated with the reserved Offer is subject to verification and compliance with these Terms. Next, the Participant must type in their favorite Qualifying Item in the Qualifying Item Form field (the "**Submission**").

If the email address provided to reserve an Offer is valid, the Participant will receive an email from confirmation@isthedominoworthypromo.com within approximately one (1) minute of AMOE Form submission with a verification code. The Participant must follow the on-screen instructions to authenticate and validate their email within five (5) minutes of completion of the AMOE Form, using the provided code, or the Offer reservation will be forfeited and reallocated to the available Offers. Once the Participant enters the provided code to complete the Offer reservation process, the Submission will be validated for inclusion of a Qualifying Item. If a Participant reserves an Offer but fails to authenticate their email address and complete the Offer reservation within the specified time, such Participant will remain eligible to reserve another Offer, subject to availability. If the Submission is validated, the Offer Claim will be confirmed and the Participant will receive an email with their "Offer Code", as detailed below, along with redemption instructions. IF THE SUBMISSION IS NOT VALIDATED, OFFER CLAIM WILL NOT BE CONFIRMED, AND PARTICIPANT WILL NOT RECEIVE AN OFFER CODE. The Participant is responsible for checking their spam folder and email settings. Promotion Entities are not responsible for lost, expired, overlooked, rejected, or misplaced authentication emails.

LIMIT ONE (1) OFFER CLAIM PER PERSON DURING THE OFFER PERIOD REGARDLESS OF METHOD OF PARTICIPATION.

Any attempt by a Participant to exceed this limitation by using multiple/different emails, identities, registrations, or any other methods will void such Participant's Offer reservation and entitlement to an Offer Claim, and such Participant may be disqualified from participating. Offer reservations or Offer Claims generated by a script, macro, or other automated means or by any means that subverts the outlined process will be void, at the sole discretion of the Promotion Entities.

4. OFFER CODES: There are 105,375 Offer Codes available (each an "Offer Code" and collectively the "Offer Codes"). Each Offer Code is valid for one (1) 3-topping "Domino" pizza (the "**Qualified Product**") and has an approximate retail value ("**ARV**") of \$9.49. Taxes, delivery charges, and tips are the sole responsibility of the ordering party.

Offer Code must be redeemed by October 14, 2026, and is void if not redeemed by the expiration date. Codes are only valid for redemption on www.dominos.com or via the Domino's app. The Offer Code cannot be redeemed in-store. If lost or stolen, the Offer Code cannot be replaced. Offer Codes cannot be sold or bartered. The Offer Code can be applied to a the "Domino" Pizza only.

5. CONDITIONS OF PARTICIPATION: Promotion Entities reserve the right, in their sole discretion, to cancel, modify, extend, or suspend the Promotion at any time for any reason. In the event of any such disruption, the Sponsor will post a notice. Participation in the Promotion constitutes the Participant's understanding of and full and unconditional agreement to these Terms. Promotion Entities reserve the right to disqualify any Participant they determine to be in violation of any terms contained herein. Data rates may apply if a Participant enters via a web-enabled mobile device. See applicable wireless service provider terms for details on rates and capabilities.

Any decision by the Promotion Entities not to enforce a specific provision of these Terms does not constitute a waiver of that provision or of the Terms generally. If there is a dispute over the identity of a Participant, the authorized account holder of the email account will be deemed the Participant. The "Authorized Account Holder" is defined as the natural person in whose name the email account was opened, if such person is otherwise eligible in accordance with these Terms. If a dispute regarding the identity of a Participant cannot be resolved to the satisfaction of the Promotion Entities, the affected Offer Claim will be deemed ineligible. Participation constitutes permission (except where prohibited by law) to use Participant's name, city, state, likeness, image, and/or voice for purposes of advertising, promotion, and publicity in any and all media now or hereafter known, throughout the world in perpetuity, without additional compensation, notification, permission, or approval. The Promotion Entities shall not be liable for any printing, typographical, human administrative, or technological errors associated with the Promotion. Sponsor may prohibit an individual from participating in the Promotion if, in its sole discretion, it determines they are attempting to undermine the legitimate operation of the Promotion by cheating, deception, or any other unfair practices or intending to annoy, abuse, threaten or harass any other Participants or Sponsor's representatives. Participants who violate these Terms, violate any law, rule, or regulation in connection with participation in the Promotion, tamper with the operation of the Promotion, or engage in any conduct that is detrimental or unfair to Sponsor, the Promotion, or any other Participant (as determined in Sponsor's sole discretion) are subject to expulsion from the Promotion. Any provision of these Terms deemed unenforceable will be enforced to the extent permissible, and the remainder of these Terms will remain in effect. The use of the terms "include" or "including" in these Terms is illustrative and not limiting.

6. INDEMNITY: Participants shall indemnify, defend and hold harmless the Promotion Entities, and each of their respective parents, affiliates, divisions, subsidiaries, franchisees, successors, assigns and licensees, and each of their respective employees, shareholders, officers, directors, contractors, advertising and promotion agencies, agents and representatives (collectively, the "**Released Parties**") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Promotion or receipt or use or misuse of any Offer provided.

7. LIMITATIONS OF LIABILITY AND RELEASES: By participating in the Promotion, Participant releases Promotion Entities, and all Released Parties from any liability whatsoever, and waives any and all causes of action, related to any claims, costs, injuries, losses, or damages of any kind arising out of or in connection with the Promotion or delivery, mis delivery, acceptance, possession, use of or inability to use any Offer Code (including claims, costs, injuries, losses and damages related to rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional), whether under a theory of contract, tort (including negligence), warranty or other theory. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL THE SPONSOR OR THE RELEASED PARTIES BE LIABLE FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, INCLUDING LOSS OF USE, LOSS OF PROFITS, OR LOSS OF DATA, WHETHER IN AN ACTION IN CONTRACT, TORT (INCLUDING NEGLIGENCE) OR OTHERWISE, ARISING OUT OF OR IN ANY WAY CONNECTED TO PARTICIPATION IN THE PROMOTION OR USE OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE PROMOTION, EVEN IF A RELEASED PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT WILL THE AGGREGATE LIABILITY OF THE RELEASED PARTIES (JOINTLY) ARISING OUT OF OR RELATING TO PARTICIPATION IN THE PROMOTION OR USE OF OR INABILITY TO USE ANY EQUIPMENT PROVIDED FOR USE IN THE PROMOTION EXCEED \$10. THE LIMITATIONS SET FORTH IN THIS SECTION WILL NOT EXCLUDE OR LIMIT LIABILITY FOR PERSONAL INJURY OR PROPERTY DAMAGE CAUSED BY ITEMS RECEIVED FROM THE SPONSOR, OR FOR THE RELEASED PARTIES' GROSS NEGLIGENCE, INTENTIONAL MISCONDUCT, OR FOR FRAUD.

8. DISPUTES: All disputes, claims, and causes of action arising out of, or connected with, this Promotion, including without limitation, any alleged violation of these Terms, any controversy relating to the arbitrability of any dispute, or any claim that the Promotion, or any part thereof, is invalid, illegal or otherwise voidable (or void), shall be resolved exclusively by arbitration to be held near Ann Arbor, Michigan under the auspices of the American Arbitration Association and according to its Commercial Dispute Resolution Rules and Procedures. Judgment upon the arbitration award may be entered in any court having jurisdiction thereof. This arbitration provision shall be deemed to be self-executing, and if either party fails to appear at any properly noticed arbitration proceeding, an award may be entered against such party notwithstanding said failure to appear. In no event shall a Participant seek or be entitled to rescission, injunctive, or other equitable relief or to enjoin or restrain the operation of this Promotion. All issues and questions concerning the construction, validity, interpretation, and enforceability of this Promotion, or the rights and obligations of Participants and Promotion Entities, shall be governed by and construed in accordance with, the laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.

9. PRIVACY: The information provided by Participants will only be used as provided in these Terms or the Sponsor's privacy policy at <https://www.dominos.com/en/#!/content/privacy/> ("**Privacy Policy**"). In the event of any conflict between these Terms and such Privacy Policy, these Terms shall control. Participants grant the Sponsor permission to share their email address and any other personally identifiable information with the corresponding Promotion Entities solely for the purpose of Promotion administration.
